The fourth meeting of the Sixth Bureau of the APMCHUD was held on 5<sup>th</sup> November on the sidelines of the World Urban Forum12, at Cairo, Egypt.

The Chairperson, Shri Manohar Lal, Republic of India was unable to personally join the meeting due to exigencies. It was informed by Democratic Socialist Republic of Sri Lanka, Islamic Republic of Iran, and Republic of Nauru that they would be unable to attend the meeting as there was no delegation at WUF12 from these countries.

H.E. Nga Kor Ming, the Hon'ble Minister of Housing and Local Government, Malaysia was invited to the Bureau meeting as a special invitee to be an observer.

Mr. Srinivas Katikithala, Secretary Ministry of Housing and Urban Affairs and Ms. Kazuko Ishigaki, Regional Representative United Nations Human Settlements Programme (UN-Habitat) Regional Office for Asia and the Pacific (ROAP), Mr. Dinesh Kapila, Deputy Chief Coordinator, APMCHUD were present along with officials of the APMCHUD Secretariat. However, the meeting could not be conducted in the absence of a quorum.

The Hon'ble Minister H.E. Nga Kor Ming, offered the commitment of the Government of Malaysia to host the next APMCHUD Bureau Meeting in Penang, Malaysia from14-15 April 2025. He assured the full and total support of the Government of Malaysia and his Ministry in particular to successfully host the meeting and extended a warm welcome to all APMCHUD members.
